# **Foyer Maryland**

Le Foyer Maryland situé dans la région Rideauview à Ottawa a ouvert ses portes au mois d'août 1988. Le Foyer Maryland fournit un programme bilingue spécialisé qui offre la gestion du poids pour des adultes ayant une déficience intellectuelle et qui ont en plus des troubles alimentaires sérieux. En ce moment le foyer Maryland dessert cinq personnes. Quatre de ces cinq personnes ont le syndrome Prader-Willi qui est causé par un défaut génétique. La plupart des personnes sont atteintes d'un léger handicap intellectuelle, qui peut-être différent selon les individus. Pour ces personnes contrôler leur poids est un défi qu'elles auront à relever toute leur vie. Le problème est aggravé par le fait qu'elles ont besoin de moins de calories pour maintenir leur équilibre métabolique. Elles ressentent plus tardivement et à un moindre degré que les autres personnes la sensation de satiété. Elles éprouvent donc davantage et plus souvent l'envie de manger. Le Foyer Maryland fournit un programme adapté aux individus. L'équipe travaille ensemble pour offrir suffisamment d'activités tout en maintenant une surveillance stricte de l'alimentation. Si un régime alimentaire hypocalorique strict accompagné d'activités physiques régulières n'est pas mis en place, ces individus développeront une obésité qui pourrait mettre leur vie en danger. Les personnes atteintes du syndrome Prader-Willi sont souvent affables et charmantes. Elles ont aussi en commun des problèmes de comportement (généralement liés à la nourriture) qui sont les suivants: crises de colère, entêtement, manque de souplesse, tendance à argumenter, à agir ou à penser de façon répétitive. Il est difficile de changer ces comportements car ils sont d'origine organiques. On peut tout de même pallier à ces problèmes en structurant mieux l'environnement des individus. Dans certains cas, l'utilisation de médicaments sous contrôle d'un spécialiste peut aussi aider. Les défis à relever par les personnes atteintes du syndrome Prader-Willi sont nombreux mais avec l'approche globale utilisée au foyer Maryland, ces personnes peuvent atteindre un certain degré d'autonomie et de sécurité, et jouir de la vie.



Most Familyhome Sharers are active in the community; they may attend a Day Program activity such as a sheltered workshop or school on a full-time basis.

All potential Familyhome Provider Applicants must go through a thorough assessment before being accepted into the Familyhome Program. This involves completion of an application, a police background check, fire and public health inspections of your home, letters of reference, a home study and an in-depth interview by the Familyhome Social Worker.

#### **EXECUTIVE DIRECTOR'S REPORT**

2001 was an active year for OCAPDD and the Developmental Services sector in both Ottawa and Ontario.

In the Provincial Budget, \$197 million was announced for infusion into our sector over a period of five years, along with another \$67 million in funding for capital projects. These funds have finally been allocated, and the following is a summary of the portion that will end up in Ottawa, and the services that will be created for individuals currently on the Registry at Service Coordination:

- Capital and operating funds have been approved to open two new group homes that will support 10 individuals (Tamir Foundation will operate one home, with the second agency still to be determined)
- Over \$130,000 has been approved to create 11 new Day Program spaces
- Over \$116,000 has been approved to support
  5 individuals in an Accommodation
  Program (other than group living)
- Over \$115,000 has been approved to support 27 individuals through Out of Home respite

The Foundations Initiative previously reported on, has continued to develop. 17 individuals are being supported through Phase I of the project, and 15 individuals will be supported through Phase II of the project. OCAPDD is supporting 3 through the Phase I component, and provided comprehensive assessments for 10 of the individuals to be served through Phase II. The Phase III proposals that have been selected for funding approval were announced recently. Unfortunately, no proposals from Ottawa were selected for funding in this Phase. I would like to again thank all of the volunteers who participated in the development and refinement of OCAPDD's proposals.

OCAPDD was successful in obtaining a grant from the Community Foundation of Ottawa, to support our efforts to create a Snoezlin Room at one of our facilities. OCAPDD is actively participating in a multi-agency initiative to seek the substantial funding required to build a full Snoezlin Room, and this donation will be of assistance with that activity. While the donor has requested to remain anonymous, we appreciate the assistance of the Foundation's efforts in communicating our needs to such a generous supporter.

Ottawa City Council recently adopted recommendations of the City Transit Transportation Committee regarding changes to Para Transpo. The first recommendation was the utilization of a 'functional assessment' rather than a 'physical assessment' for eligibility. Certainly this has been an area of lobbying from our sector for many years, and appears to be a positive development. The requirement for attendants remains for many however, so the actual impact of the changes will need to be monitored in the future. The Ontario Government passed Bill 57 in June of this year. One item within this omnibus Bill was the exclusion of any agency funded under the Developmental Services Act from HLDAA (Hospital Labour Disputes Arbitration Act). As previously reported and discussed, labour relations within OCAPDD are currently governed by HLDAA. However, upon the expiration of the next collective agreement with CUPE Local 1521, OCAPDD will no longer be considered a 'hospital' and governed by HLDAA. The actual date of that change will not be known until the next collective agreement is awarded through binding arbitration, but will not be before April 2003.

As you are probably aware, December 3<sup>rd</sup> was the International Day of Disabled Persons. The objectives of the Day were to promote increased awareness of disability issues, and to mobilized support for practical action to improve the wellbeing and life of persons with disabilities on the basis of equality.

On November 30<sup>th</sup>, Lieutenant Governor Hilary Weston and Minister of Community & Social Services John Baird signed the proclamation to repeal the Homes for Retarded Persons Act (HRPA). The HRPA had been enacted in 1966 to regulate group homes for adults with developmental disabilities.

"Families caregivers had continuously and expressed to me that the act was inappropriate and demeaning," said Baird. "As part of our commitment to people with developmental disabilities, we have updated laws to make them current, clearer, and more sensitive to the people The Government's 5-year budget they serve." commitment to invest \$197 million in the developmental services sector was reaffirmed in the package of information released with this announcement.

## Programme francophone de Répit

Service de répit aux personnes ayant une déficience intellectuelle.

*Philosophie*: procurer du repos aux familles qui hébergent et aident des personnes (enfants et / ou adultes) ayant une déficience intellectuelle. Ainsi les clients peuvent vivre dans leur milieu familial le plus longtemps possible et promouvoir l'indépendance chez la personne.

*Mode de fonctionnement:* le programme offre des sessions de dix jours. Ces sessions peuvent varier selon les besoins de chaque famille. Nous avons une session pour les adultes et une session pour les enfants chaque mois.

De plus, il y a un service d'urgence afin d'accommoder les situations imprévues, par exemple, maladie, décès, incendie et autres.

Activités: natation, restaurants, parcs, pique-niques, cinéma, danses, patin, parc oméga, aventure cosmique, piscines à vagues, musées, ferme expérimentale, usine Hershey et magasinage.

**Buts:** repos, urgences, exercices, conscience sociale, développement personnel, rencontres, découverte, transport, transition et activités sociale.

Équipe: notre équipe comprend cinq personnes qualifiées dans le domaine des services sociaux. Nos employés(ées) reçoivent une formation permanente: réanimation cardio-respiratoire, premiers soins, intervention en situation de crises, WHIMS. Tout nouvel employé doit fournir une preuve d'un service de police comme quoi il n'a aucun antécédent judiciaire.

Demande d'admission: il faut remplir un formulaire de demande d'admission accompagné d'un rapport médical et d'hépatite «B». Il est également nécessaire de signer un consentement à l'administration de médicaments prescrits et non-prescrits ainsi que le formulaire 14 de l'Acte de la santé mentale du gouvernement de l'Ontario. Nous devons connaître les habitudes alimentaires (allergies et régimes particuliers) de nos clients et obtenir une photo pour établir leurs profils.
